NOTIFICATION

The Directorate of Elementary Education, Govt. of Arunachal Pradesh has decided to conduct the 9th State Level Teacher Eligibility Test (APTET) 2019 in accordance with provisions of Section 23 (I) of RTE Act 2009 as it is one of the eligibility criteria under NCTE Guidelines for the person aspiring to become teacher at Elementary Level in the schools of Arunachal Pradesh.

A candidate applying for APTET'2019 should meet the following criteria/requirements:

A. Primary Level (Class I to V):

1. Maximum Age: 30 years as on 01/01/2020 (age relaxation to APST candidates as per norms)
2. **Educational Qualifications :**
Senior Secondary (or its equivalent) with 50% marks and 2-years Diploma in Elementary Education (by whatever name known).

OR

Senior Secondary (or its equivalent) with at least 50% marks and 4-years Bachelor of Elementary Education (B.El.Ed)

OR

Senior Secondary (or its equivalent) with at least 50% marks and 2-years Diploma in Education (Special Education)

OR

Graduation and Two years Diploma in Elementary Education (by whatever name known)

B. Upper Primary Teacher (Class VI to VIII):

1. Maximum Age: 35 years as on 01/01/2020 (age relaxation to APST candidates as per norms)
2. **Educational Qualifications:**
Graduation and 2- years Diploma in Elementary Education (by whatever name known)

OR

Graduation with at least 50% marks and 1-year Bachelor in Education (B.Ed)

OR

Senior Secondary (or its equivalent) with at least 50% marks and 4-years Bachelor in Elementary Education (B.El.Ed)

OR

Senior Secondary (or its equivalent) with at least 50% marks and 4-years B.A-B.Ed/B.Sc. B.Ed
3. **Reservation:** Relaxation upto 5% in qualifying marks for the candidates of reserved category as per State Govt. norms.
4. D.El.Ed/B Ed. Course from NCTE recognized institution and Diploma in Special Education and B.Ed (Special Education) organized by Rehabilitation Council of India (RCI) shall only be considered.

N.B:

1. Qualifying the APTET'2019 would not confer a right on any person for recruitment/ employment as it is only one of eligibility criteria for appointment.
2. It is also noted that if a candidate has been allowed to appear in APTET'2019, it does not imply that the candidate's eligibility has been verified. It does not vest any right with the candidate for appointment. The eligibility shall be finally verified by the concerned recruiting /appointing authority.
3. Furnishing of false, wrong or inaccurate information may lead to cancellation of the test result, forfeiture of certificate and even prosecution.
4. Only NCTE recognized B.Ed / D.El.Ed certificate will be considered.
5. "Appearing Candidates" means the students of final semester of qualifying exam only are eligible to apply for APTET'2019.
